

Announcement of Nong Muang Police Station story Anti-Bribery Police and No Gift Police Policy for Fiscal Year bobs

According to the Organic Act on the Prevention and Suppression of Corruption B.E. (७०६), Section ६०६, paragraph one, prohibits any public official from receiving property or any other benefit which may be calculated as income from anyone other than the property or legitimate interest. Rules or regulations issued by virtue of the provisions of law, except for the receipt of other property or other benefits. By virtue of the rules and numbers of the Board of Directors. NCC and Police Code of Ethics B.E. (१००६) Article (१०) Honesty, honesty, and compliance with the law The Royal Thai Police's formalities with transparency do not show any behavior that implies exploitation and abuse of responsibility for human rights duties. Be ready for audit and liability And Article (१८) thinks of the common good rather than personal benefit. Public spirit, cooperation, cooperation and sacrifice in doing good for the common good and creating happiness for society In addition, the plan for major reforms Activity & Develop the Thai bureaucracy to be transparent and without benefits. Goal (Article (6.6) All government agencies where all government officials do not accept gifts and gifts of any kind from the performance of their duties. (No Gift Police)

Therefore, in order to prevent conflicts between self-interest and the common good. (Conflict of Interest) Accepting bribes, gifts, gifts, or any other benefits that affect the performance of duties, Nong Muang Police Station has established guidelines for anti-graft practice. (Anti-Bribery Police) and not accepting gifts, gifts, or any other benefits. (No Gift Police) The details are as follows:

- ©.To prevent or reduce the chance of receiving bribes. Conflict of interest in various forms to police officers under Nong Muang Police Station
- b. To encourage police officers under Nong Muang Police Station to be conscious of refusing to accept gifts and gifts of all kinds from the performance of their duties.
- m. To create a corporate culture of integrity and transparency. (Organization of Integrity) of the bureaucracy to be strong and sustainable.

- ๔. To determine measures Guidelines and mechanisms to prevent giving/accepting bribes or other benefits
- &. To determine guidelines for receiving certification fees or gifts of executives and police officers under Nong Muang Police Station in accordance with relevant laws and regulations.
- 5. To support and enhance the implementation of the National Strategy, the Master Plan under the National Strategy and the National Reform Plan on Prevention and Suppression of Corruption and Misconduct, as well as be part of the guidelines for assessing morality and transparency in government agencies. (ITA)

Scope of applicability

Applicable to police officers under Nong Muang Police Station. All Mr.

meaning

"Bribe" means property or other benefits given to a person in order for him or her to act or refrain from doing any act in his or her office. Whether it is legitimate or unlawful as the bribe payer wants.

"Gifts, gifts, or any other benefits affecting the performance of duties" means money, property, services or any other benefit of value and including tips received by public officials in addition to their salaries. Income, benefits from the government in normal cases and affect decision-making. approval Permit, authorize, or otherwise perform duties in a manner that favors dishonestly the gift-giver, either in the past or at the time of receiving or in the future.

"Property" means property and intangible objects that may have a price and may be held, such as money, houses, cars, stocks.

"Receiving property or any other benefit by virtue" means receiving property or any other benefit from relatives or persons who give to each other on various occasions, usually according to custom. or give to each other according to the etiquette practiced in society.

"Relative" means a descendant who is a co-parent or co-parent. Uncles, aunts, uncles, spouses Spouse's parent or successor, adopted child or adoptee

"Any other benefit" means something of value, including discount, entertainment, service, training, or the like.

"Performance" means the act or performance of a public officer in a position appointed or assigned to perform a particular duty or to act on his behalf in any particular duty, both general and specific, as a police officer for which the authority of the law has been defined, or in accordance with the authority specified by law.

Guidelines for preventing graft

- ø. Police officers under Nong Muang Police Station are prohibited. Engage in giving or accepting bribes in any form, whether directly or indirectly.
- b. Police officers under Nong Muang Police Station are prohibited. Demand or accept bribes for personal gain or the benefit of another person.
- m. Comply with the Anti-Corruption Policy without being involved in corruption whether directly or indirectly.
- «. The performance of duties shall comply with the regulations. Police discipline and related laws are strictly enforced.
 - &. Do not commit any act that is considered to be giving or accepting bribes.
- ъ. Supervise the disbursement of expenses of subordinate agencies in accordance with the law. Strictly relevant regulations
- ଖ. Receiving donations or supports, whether it is money objects or property to any activity or project. Regulations must be followed. And there is a receipt or proof of receipt to accompany the report every time.
- ಡ. Receiving property or other benefits by virtue of the Code of Conduct, all police officers under Nong Muang Police Station shall comply with the announcement. The National Anti-Corruption Commission strictly enforces the criteria for receiving assets or other benefits by the Code of Conduct of Officials B.E. ២៥៤៣ (២೦೦೦).

Punitive measures/violations of guidelines

- **b**. Failure to be aware of this Policy Notice and/or related laws It cannot be used as an excuse for non-compliance.
- ണ. The supervisor under Police Department Order No. െ ഉടെ/െർ dated October െ, െർർ has the authority and duty to supervise and supervise the subordinates under the administration to strictly adhere to and comply with this policy.

Monitoring measures

- Superintendent of Nong Muang Police Station Declare the intention to manage the agency honestly, honestly, transparently and in accordance with good governance principles by disseminating information to subordinate police officers and external stakeholders.

under his control. The subordinates shall comply with this notice. In case of any violation of this notice, report to the Superintendent of Nong Muang Police Station as soon as possible.

- m. Nong Muang Police Station will conduct an annual audit and evaluation of compliance with this guideline and arrange for a review and improvement of the compliance guidelines as appropriate or at least once a year or according to significant changes in various factors.
- «. The administration department of Nong Muang Police Station shall prepare statistics on receiving gifts or other benefits along with obstacles. The solution is then reported to the Superintendent of Nong Muang Police Station. Know every quarter

Protection measures for claimants/whistleblowers confidentiality

<u>Protection measures for petitioners and witnesses</u>

- െ. Consideration of complaints: The confidentiality layer shall be determined and the protection of related persons shall be determined in accordance with the Regulation on Government Confidentiality B.E. ഉഷ്ഷ് (ഉരാത) and the submission of the matter to the agency for consideration. The circumstances are evident, and only definite individual witnesses are identified. Whistleblowing influencers must conceal the petitioner's name and address. If the name and address of the petitioner are not concealed, the relevant authorities must be notified and provided with protection to the petitioner as follows: "The supervisor shall exercise reasonable discretion and order to protect the petitioner, witness and the person providing information in the investigation and not to suffer any harm or injustice that may arise from the complaint, witnessing or providing such information." In the event that the name of the accused is identified, both the petitioner and the respondent must be protected as the matter has not yet gone through the scrutiny process. In the event that the complainant states in the request for anonymity or does not wish to disclose the name of the complainant, the agency must not disclose the name of the petitioner to the respondent agency. This is because the petitioner may have suffered according to the cause of the complaint.
- b. When there is a complaint The petitioner and the witnesses will not take any action that affects their job or livelihood duties. If any action is necessary, such as separation of workplaces to

prevent the petitioner, witnesses and the accused from meeting, etc. The consent of the petitioner and witnesses is required.

- m. Victim's request Petitioners or witnesses, such as requests for relocation of workplaces or methods to prevent or solve problems, should be considered by the person or responsible agency as appropriate.
 - a. Protect the complainant from bullying.

Protection measures for the accused

- o. During the hearing of the complaint, the accused is not considered guilty. They must be treated fairly and treated the same as other people.
- **b**. Give the accused a full opportunity to clarify the allegations, including the right to present documents/evidence.
